

INTERLOCAL AGREEMENT BETWEEN CITIES INSURANCE ASSOCIATION OF WASHINGTON (CIAW), UNITED SCHOOLS INSURANCE PROGRAM (USIP), SCHOOLS INSURANCE ASSOCIATION OF WASHINGTON (SIAW) AND THE WASHINGTON RURAL COUNTIES INSURANCE PROGRAM (WRCIP) TO DELINEATE THE CONTRACTUAL RELATIONSHIP FOR THE PURCHASE OF A DRIVING SIMULATOR TRUCK AND TRAILER AND TO MEMORIALIZE THE REDUCED RATE FOR THE USE OF THE TRUCK AND TRAILER FOR RISK MANAGEMENT TRAINING.

This agreement, pursuant to Chapter 39.34 of the Revised Code of Washington, is entered into between the CITIES INSURANCE ASSOCIATION OF WASHINGTON (hereinafter "CIAW"), UNITED SCHOOLS INSURANCE PROGRAM (hereafter "USIP"), SCHOOLS INSURANCE ASSOCIATION OF WASHINGTON (hereafter "SIAW"), and WASHINGTON RURAL COUNTIES INSURANCE PROGRAM (hereafter "WCRIP") regarding buying down the usage rates for the Driving Simulator truck and trailer.

RECITALS

This Agreement is entered into on the basis of the following understandings, facts and assumptions:

1. CIAW, USIP, SIAW, and WCRIP, through their respective boards, have declared their intent to create a relationship wherein they jointly use a driving simulator, truck and trailer for the sole purpose of training and educating program members and non program members regarding risk management in the area of driving.
2. All previous Interlocal Agreements regarding the Driving Simulator truck and trailer are hereby null and void.
3. The purpose of this Interlocal Agreement is to set forth the relationship of the parties in respect to ownership of the Driving Simulator truck and trailer.

AGREEMENT

ACCORDINGLY, and in reference to the foregoing, the parties agree as follows:

1. The duration of this agreement shall be an annual rolling contract.
2. The parties are entering into a joint agreement to use the driving simulator truck and trailer for education and training purposes at a reduced rate. This joint agreement is not intended to create any partnership or other independent entity.
3. Each party (USIP, SIAW and WRCIP) agree they shall each be responsible for a onetime payment of \$24,576.75. Canfield shall be authorized to pay the invoice/invoices on behalf of the CIAW and collect from each program the authorized amounts for the said invoice/invoices.

4. The sole ownership of the driving simulator truck and trailer and other ancillary assets shall be retained with CIAW, and as such CIAW will be solely responsible for all maintenance, fuel, repairs, etc.
5. In consideration of the \$24,576.75 payment, SIAW, USIP, and WRCIP shall receive a reduced usage rate for the useful life of the driving simulator, truck and trailer. The reduced usage rate will be evaluated annually for the CIAW Board.
6. SIAW, USIP, and WRCIP agree to release all interest in the prior Driving Simulator, truck that was purchased in 2008.
