AUDIT SUMMARY

Results in brief

In the areas we audited, Program operations complied with applicable requirements and provided adequate safeguarding of public resources. The Program also complied with state laws and regulations and its own policies and procedures in the areas we examined.

About the audit

This report contains the results of our independent accountability audit of the Cities Insurance Association of Washington from December 1, 2014 through November 30, 2016.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the Program's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Third Party Administrator payments
- Simulator expenses
- Legal compliance (consultant bidding and claims payments)

INFORMATION ABOUT THE PROGRAM

The Cities Insurance Association of Washington (CIAW) is a public entity risk program that provides comprehensive property and liability coverage. Founded in 1988 with 32 cities, the Program has since expanded to include special purpose districts among its membership.

An elected, nine-member Board governs the Program. Directors are elected from member districts. The Program does not have any employees of its own; it contracts with a private firm for claims administration and risk management services. For fiscal years 2015 and 2016, the Program operated on annual budgets of \$11.2 and \$11.5 million, respectively.
