AUDIT RESULTS

Results in brief

This report describes the overall results and conclusions for the areas we examined. In those selected areas, Program operations complied, in all material respects, with applicable state laws, regulations, and its own policies, and provided adequate controls over the safeguarding of public resources.

In keeping with general auditing practices, we do not examine every transaction, activity, policy, internal control, or area. As a result, no information is provided on the areas that were not examined.

About the audit

This report contains the results of our independent accountability audit of the Cities Insurance Association of Washington from December 1, 2020 through November 30, 2022.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

This audit was conducted under the authority of RCW 43.09.260, which requires the Office of the Washington State Auditor to examine the financial affairs of all local governments. Our audit involved obtaining evidence about the Program's use of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters. The procedures performed were based on our assessment of risks in the areas we examined.

Based on our risk assessment for the years ended November 30, 2022 and 2021, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. We examined the following areas during this audit period:

- Calculation of member assessments
- Receipting timeliness and completeness of deposits
- Accounts payable general disbursements and transfers
- Open public meetings compliance with minutes, meetings and executive session requirements
- Financial condition reviewing for indications of financial distress and solvency compliance

INFORMATION ABOUT THE PROGRAM

The Cities Insurance Association of Washington (CIAW) is a public entity risk program that provides comprehensive property and liability coverage. Founded in 1988 with 32 cities, the CIAW has since expanded to include special purpose districts among its membership.

An elected, 10-member Board governs the Program. Directors are elected from member districts. The Program does not have any employees, and contracts with a private firm (Clear Risk Solutions) as its third-party administrator, for accounting, claims administration, risk management and other services. For fiscal years 2021 and 2022, the Program reported operating revenues of \$14.8 million and \$16.9 million, respectively.
